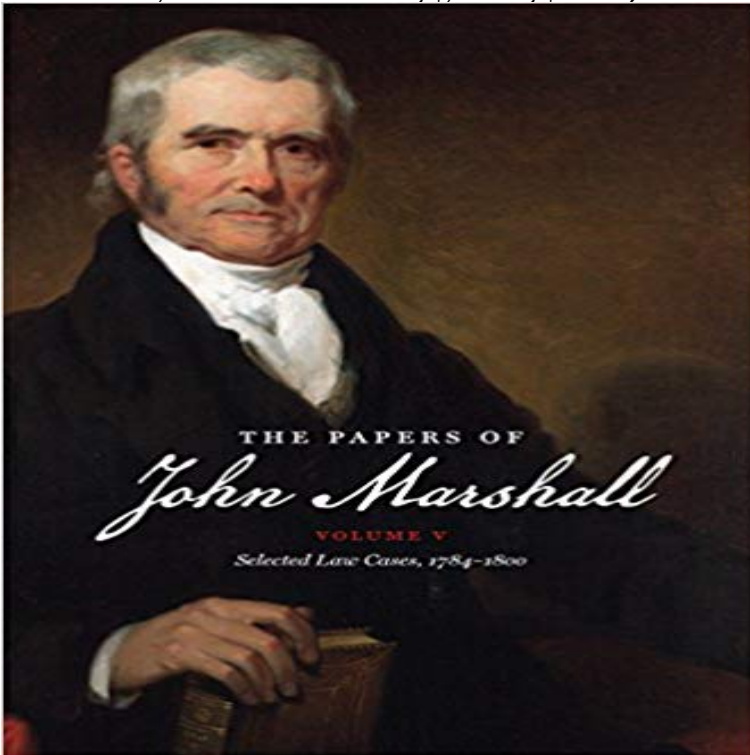

The documents presented in these volumes--with introductory material and notes--shed light not only on Marshalls life and thought but on the evolution of American jurisprudence as well.
