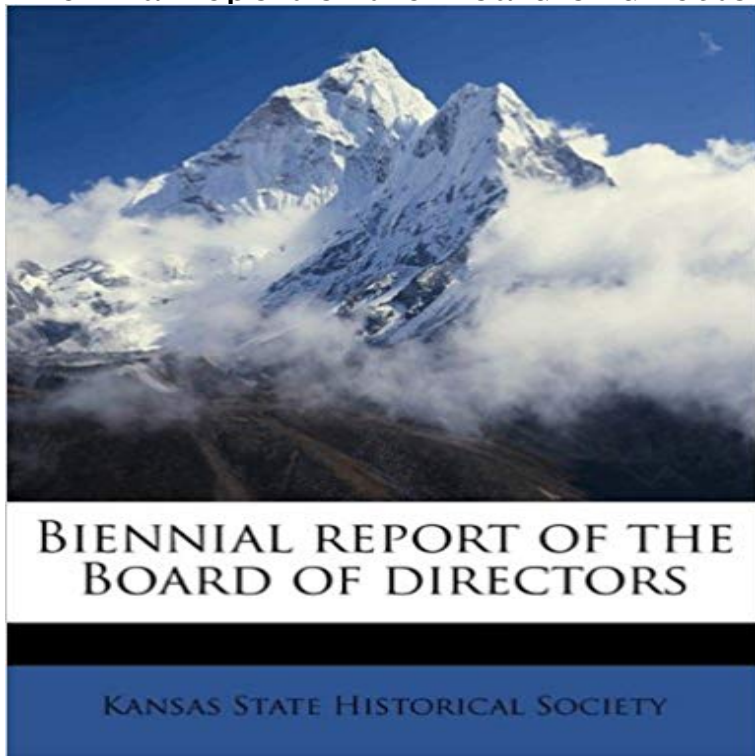


Biennial report of the Board of director
