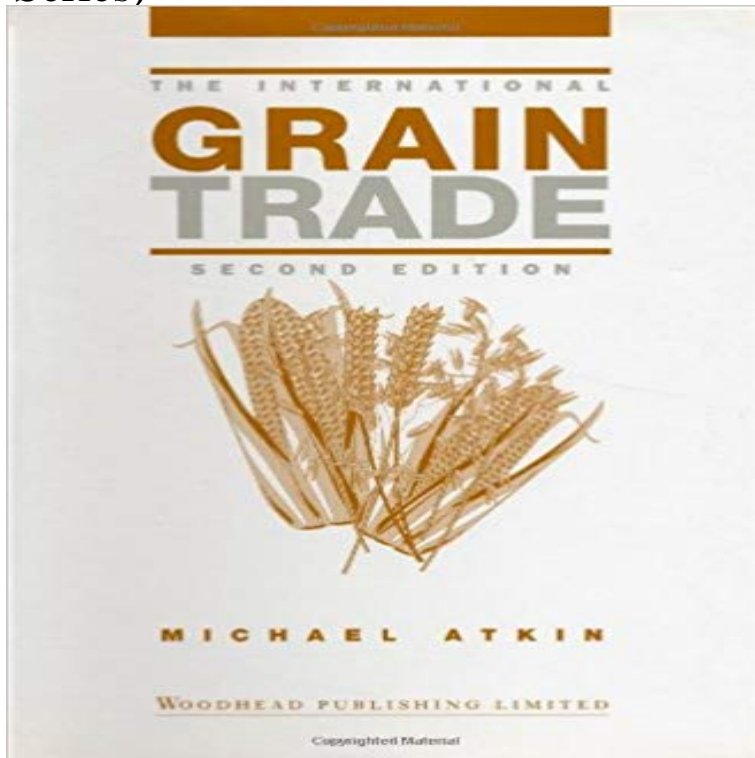


The International Grain Trade, Second Edition (The International Trade Series)
