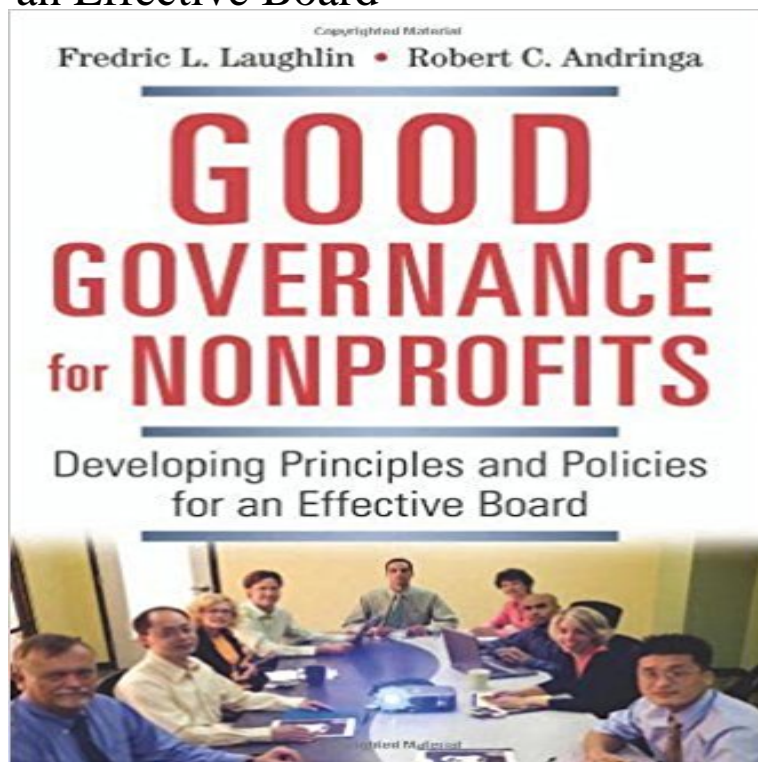


# Good Governance for Nonprofits: Developing Principles and Policies for an Effective Board
