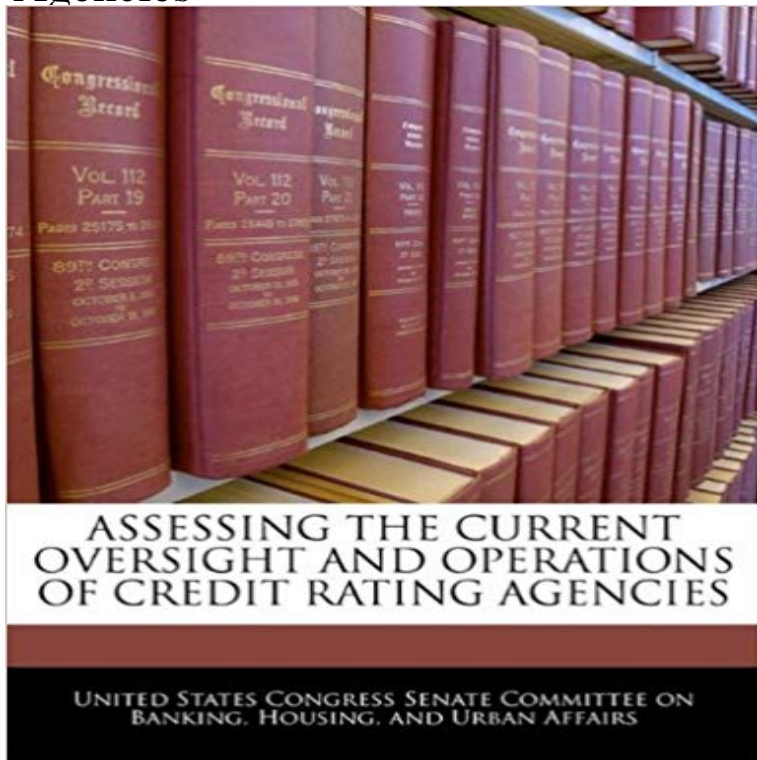


# Assessing The Current Oversight And Operations Of Credit Rating Agencies
