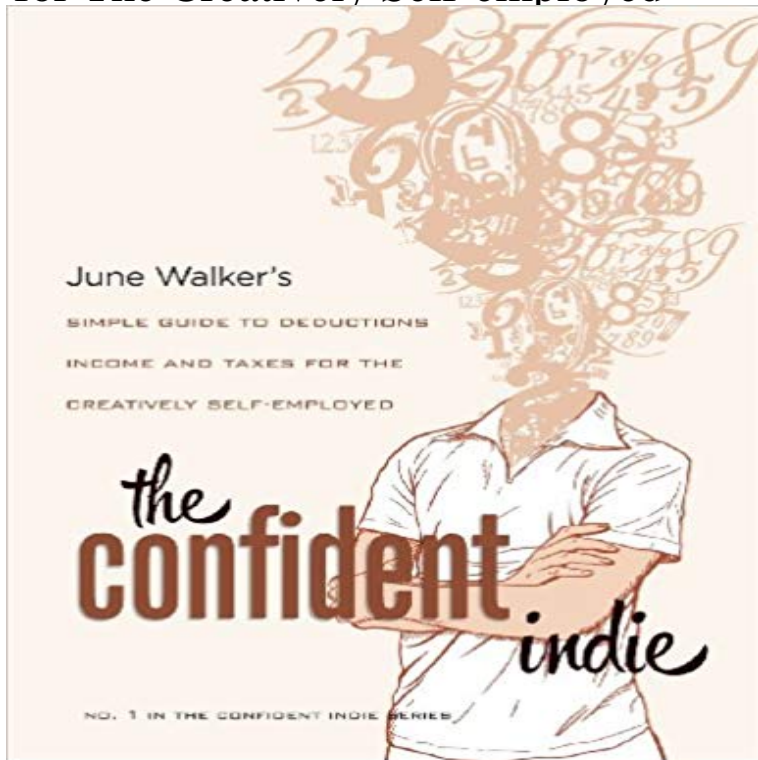


# The Confident Indie: A Simple Guide to Deductions, Income and Taxes for The Creatively Self-employed
