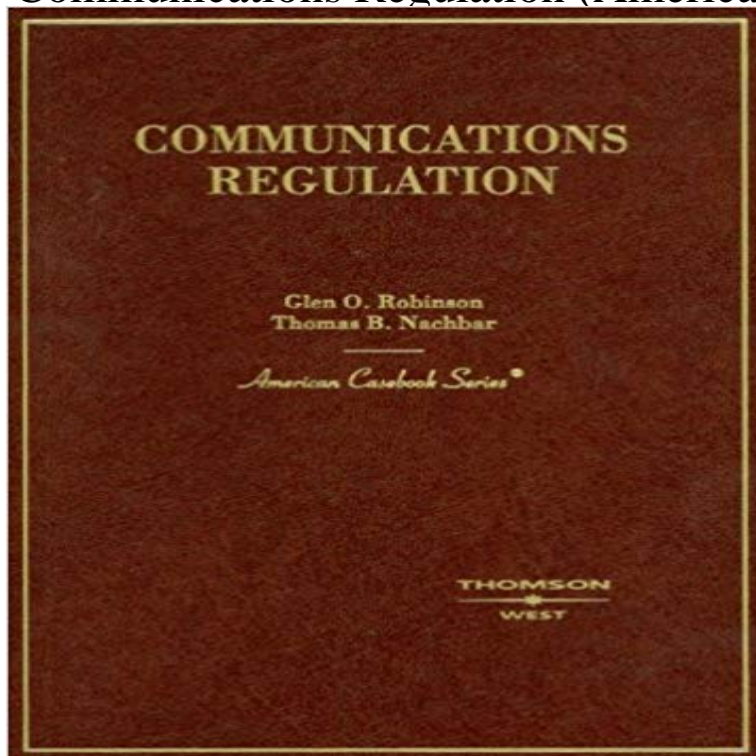


Communications Regulation (American Casebook Series)
